Chris continues: **”Regarding our upcoming meeting 3/7/2013**, we will have the privilege to hear from Brother Gary T. Wright who will be speaking about *Preserving Your Family History Records Digitally* and who asks us the question, *While gathering family history records over the years, you've probably been preserving them physically. So why consider preserving them digitally now? There are benefits and challenges of using digital preservation to both augment and enhance the preservation of your family story records. Solutions to these challenges and identifying what types of family history records are suitable for digital preservation as well as a summary of what is required to get started archiving digital records will be presented. If you are already archiving digitally, it is important to know the limitations of currently used popular media such as CDs, DVDs etc. Alternative and improved options are available and will be explored. In other words, how do you best organize what you already have and, if beginning to digitize, what is the best way to get off on the right foot.*

*Gary is currently Senior Product Manager of Digital Preservation for the Church History Department, previously holding the same position at Family Search. He has earlier provided professional services for storage technology companies such as IBM, HP and Storage TEk. He is an engineer, author, award-winning composer and plays the violin with the Orchestra at Temple Square.*

All three institutes contacted have now been sent the following email message: *The Salt Lake Chapter of the Sons of the Utah Pioneers will award a \$500 scholarship to one of your students who you or your selection committee feel has written the best*

*account of the events that led to the conversion of one of his or her ancestors or if he or she is himself or herself the first convert (i.e., "pioneer") to the church, the events that led to his or her conversion.*

The name of the student that you have selected must be submitted to us by or before April 26, 2013 and he or she must be willing to attend our May 2nd dinner meeting to deliver the winning essay. Also, we would invite you, one or two guests of the student chosen, and 3 or 4 other students who had also submitted outstanding accounts to be our guests that night at the dinner free of charge but please let us know how many will be coming.
